All interested persons are invited to present their views and comments on this matter at the public hearing. Written protests may be filed with the City Clerk either in writing or by email ([jlindgren@elkgrovecity.org](mailto:jlindgren@elkgrovecity.org)) at any time prior to the close of the hearing scheduled herein. If written protests are filed by a majority of the affected parcel owners, the proposed rate increases will not be imposed.

If you challenge the subject matter in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice or in written correspondence delivered to the City Clerk, 8401 Laguna Palms Way, 1<sup>st</sup> Floor, Elk Grove, CA, 95758, at or prior to the close of the public hearing.
