

RESOLUTION NO. 2002-215

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 5, 2002, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a general municipal election was held and conducted in the City of Elk Grove, California, on Tuesday, November 5, 2002, as required by law; and

WHEREAS, notice of the election was given in the time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects, the election was held and conducted and the ballots were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to Resolution No. 2002-65, adopted May 1, 2002, the Sacramento County Registrar of Voters canvassed the returns of the election and has certified the Statement of Results to this City Council, the results are received, attached and made a part hereof as "Exhibit A."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ELK GROVE, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. That the names of persons voted for at the election for member of the City Council are as follows:

Council District 2

Rick Soares
Tim Davies

Council District 4

Dan Briggs
Pat Perez
Rick West
Jim Cook

That the measure voted upon at the election is as follows: **Measure O.**

Section 3. That the number of votes given to each of the persons above named for the respective offices for which the persons were candidates and for and against the measure were listed in Exhibit "A", attached.

Section 4. The City Council does declare and determine that: Rick Soares was elected from Council District 2 as a member of the City Council for the full term of four years; Dan Briggs was elected from Council District 4 as a member of the City Council for the full term of four years;

Section 5. That the City Council does declare and determine that a majority of the voters voting on Measure O relating to establishing the City of Elk Grove base year appropriation limit at \$22,040,000, did vote in favor of it, and that the measure was carried, as certified to in the Certificate of Facts, Exhibit "B", and shall be deemed adopted and ratified.

Section 6. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected, the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.


Section 7. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
