

RESOLUTION NO. 2003-115

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
APPROVING THE ADOPTION OF THE 2003/04-2007/08 CONSOLIDATED PLAN,
APPROVING THE ADOPTION OF THE 2003/04 ACTION PLAN, AND AUTHORIZING
THE CITY MANAGER TO EXECUTE AND FILE ALL DOCUMENTS REQUIRED TO
RECEIVING COMMUNITY DEVELOPMENT BLOCK GRANT FUNDING**

WHEREAS, the Community Development Block Grant Program, authorized pursuant to Title 1 of the Housing and Community Development Action of 1974, as amended (Act), requires that jurisdictions receiving certain federal funds develop a Consolidated Plan and provide for the issuance of grants in order to attain the objective of the development of viable urban communities, by providing decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low and moderate income; and

WHEREAS, the City Council reviewed the 2003/04-2007/08 Consolidated Plan (Consolidated Plan) which presents a five-year strategy for meeting identified housing and community development needs and the 2003/04 Action Plan (Action Plan) which describes programs to be funded, in compliance with the goals and objectives of the Consolidated Plan, for the 2003/04 program year; and

WHEREAS, the City Council reviewed Certifications to the U.S. Department of Housing and Urban Development (HUD), including those regarding affirmatively furthering fair housing, anti-displacement and relocation plan, drug free workplace, anti-lobbying, authority of jurisdiction, consistency with strategic plan, citizen participation, community development plan, following Consolidated Plan, use of funds, prohibition of excessive force, compliance with anti-discrimination laws, and lead-based paint; and

WHEREAS, there has been presented to, and reviewed by this City Council an application on Standard Form 424 (Application) to HUD for a Community Development Block Grant in the amount of approximately \$498,000 for the period of July 1, 2003 through June 30, 2004; and

WHEREAS, there has been prepared a Notice of Exemption, pursuant to the California Environmental Quality Act (CEQA), and an Environmental Finding Form, pursuant to the National Environmental Policy Act (NEPA), determining that the adoption of the Consolidated Plan, the adoption of the Action Plan, and approval of the Application for submittal to HUD is, respectively, not considered a project under CEQA and is exempt from NEPA; and

WHEREAS, the Consolidated Plan, Action Plan, a summary of information in the plans, and a notice of the 30-day public comment period, have been published and are available for review in Community Development for citizen comment prior to City Council approval; and

WHEREAS, the City Council held a public hearing on the Consolidated Plan and Action Plan to provide an opportunity for the public to comment on the information provided in the Consolidated Plan and Action Plan.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:


1. Approves the adoption of the City of Elk Grove 2003/04 – 2007/08 Consolidated Plan substantially in the form presented to the City Council at the public hearing held on June 4, 2003.
2. Approves the adoption of the City of Elk Grove 2003/04 Action Plan substantially in the form presented to the City Council at the public hearing held on June 4, 2003, certifying that that the City of Elk Grove has and will continue to conduct its activities in accordance with applicable statutes and regulations governing the Consolidated Plan and CDBG Program, as identified in the Certifications in Appendix C of the Consolidated Plan.
3. Authorizes the City Manager to execute and file the Application, Certifications, and all documents, including the Consolidated Plan and Action Plan that are required to receive CDBG funding for and on behalf of the City of Elk Grove.
4. Approves that this Resolution shall be effective upon the date of its adoption.
