**WHEREAS**, the City of Elk Grove requires a public outreach program for the Elk Grove Boulevard Old Town Improvement Project, including the identification of stakeholders, interviews, conducting workshops, communications outreach, and development of strategies and tactics to mitigate any adverse impacts to businesses and local residences during project construction; and

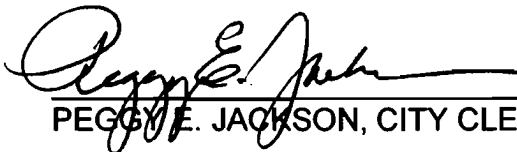

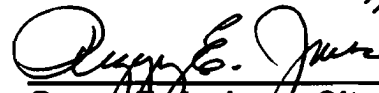
