**WHEREAS**, on July 2, 2003 the City Council authorized the award of a contract to California Pavement Maintenance Company, Inc. to perform the Slurry Seal 2003 Project; and

**WHEREAS**, the contract called for placement of slurry seal treatment on various streets within the City; and

**WHEREAS**, California Pavement Maintenance Company, Inc. has completed the work for the Slurry Seal 2003 Project in accordance with the special provisions and standard construction specifications; and

**WHEREAS**, if no liens or claims have been filed within thirty-five days of filing the Notice of Completion, retention and any remaining amount for the project will be released to California Pavement Maintenance Company, Inc.


