

**RESOLUTION NO. 2003-255**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
CERTIFYING THE NEGATIVE DECLARATION REGARDING POTENTIAL  
ENVIRONMENTAL IMPACTS AND ADOPTING THE CITY OF ELK GROVE SOURCE  
REDUCTION AND RECYCLING ELEMENT (SRRE) AND THE CITY OF ELK GROVE  
HOUSEHOLD HAZARDOUS WASTE ELEMENT (HHWE)  
FOR THE CITY OF ELK GROVE**

**WHEREAS**, the City Council recognizes that it is in the public interest to enact and implement an integrated waste management plan to address both the State's diminishing landfill capacity and the City's available landfill disposal alternatives as well as emphasize the conservation of natural resources; and

**WHEREAS**, the City of Elk Grove is required by Chapter 2 of Division 30 of the California Public Resources Code to prepare, adopt, and submit to the California Integrated Waste Management Board and the County of Sacramento, a Source Reduction and Recycling Element (SRRE); and

**WHEREAS**, the City of Elk Grove is required by Chapter 3.5 of Division 30 of the California Public Resources Code to prepare, adopt, and submit to the California Integrated Waste Management Board and the County of Sacramento, a Household Hazardous Waste Element (HHWE); and

**WHEREAS**, the SRRE and the HHWE have been prepared in accordance with state guidelines and regulations as issued in Title 14 of the California Code of Regulations; and


**WHEREAS**, on December 17<sup>th</sup>, 2003, the City Council of the City of Elk Grove conducted a public hearing to receive and consider comments on the environmental review of the SRRE and HHWE and the Final Drafts of the SRRE and the HHWE prior to the adoption of the Final Drafts of the SRRE and the HHWE.

**NOW THEREFORE, BE IT RESOLVED** by the City Council of the City of Elk Grove that the City Council certifies the negative declaration concerning potential environmental impacts and adopts the Source Reduction and Recycling Element and the Household Hazardous Waste Element for the City.




