A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPOINTING KENT BASTAIN AS HEARING OFFICER TO CONDUCT AN ADMINISTRATIVE HEARING UNDER THE CITY'S STORM WATER MANAGEMENT DISCHARGE CONTROL ORDINANCE NO. 22-2003 IN RESPONSE TO A REQUEST FOR AN ADMINISTRATIVE APPEAL TO NOTICES OF NON-COMPLIANCE ISSUED TO LENNAR COMMUNITIES, INC.

WHEREAS, the City has issued Notices of Non-Compliance to Lennar Communities, Inc. on February 13, 16, and 19, 2004 that requires an Administrative Hearing officer for an appeal hearing; and

WHEREAS, the City's Storm Water Management and Discharge Control Ordinance No. 22-2003 specifies that the City Council must appoint the hearing officer; and

WHEREAS, the City was prepared to enter into a long-term contract for hearing officer services, but that contract fell through two days before the City Council meeting at which the contract was to be approved; and

WHEREAS, the statutory timeline for conducting the administrative hearing regarding the administrative appeal from the Notices of Non-Compliance issued to Lennar Communities, Inc. on February 13, 16, and 19, 2004 expires before the next regularly scheduled City Council meeting; and

WHEREAS, Kent Bastian, of the City of West Sacramento's Department of Public Works, has agreed to act as the hearing officer;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Elk Grove as follows:

1. There is a need to take immediate action and that the need for action came to the attention of the City of Elk Grove subsequent to the agenda being posted as specified in the Brown Act.

2. The City Council hereby appoints Kent Bastian of the City of West Sacramento's Department of Public Works as the hearing officer to conduct an administrative hearing under the City's Storm Water Management and Discharge Control Ordinance No. 22-2003 in response to a request for an administrative appeal to Notices of Non-Compliance issued to Lennar Communities, Inc. on February 13, 16, and 19, 2004.
