#### **RESOLUTION NO. 2004-278**

# A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DECLARING THE RESULTS OF AN ELECTION HELD REGARDING STORM DRAINAGE FEES

WHEREAS, the City Council (the "Council") on July 21, 2004, duly adopted its Resolution No. 2004-173 (the "Resolution of Intention"), which proposed levying storm drainage fees according to the procedures and methodology described in Ordinance No. 15.10, adopted by the Council on June 18, 2003, but at a unit service charge rate described in the Resolution of Intention (the "Storm Drainage Fees"), on all remaining properties within the City that currently are neither subject to taxes used to pay for storm drainage nor subject to storm drainage fees and as more fully identified on Figure 1 attached to the South Elk Grove Storm Water Drainage Utility Fee Analysis Report dated September 2004 (the "Property"); and

WHEREAS, the Council on September 15, 2004, duly adopted its Resolution No. 2004-241 (the "Resolution Calling Election"), which ordered an election concerning the levy of the Storm Drainage Fees on the Property to be held on November 9, 2004; and

WHEREAS, the City Clerk has duly canvassed the returns of the election as required by the Resolution Calling Election and has filed with the Council a statement of all votes cast at the election showing the number of votes cast for and against the proposed levy and also filed, attached to the statement, her certificate as to the correctness of the statement (the "Statement of Election Results"), which is attached hereto as Exhibit A.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Elk Grove that:

**Section 1.** Recitals. The foregoing recitals are true and correct.

<u>Section 2</u>. <u>Canvass</u>. The canvass by the City Clerk as shown by the Statement of Election Results is hereby ratified, confirmed, and approved. A majority of all the votes cast at the election were in favor of levying the Storm Drainage Fees on the Property, and the levy of the fees was approved.

<u>Section 3.</u> Levy of Storm Drainage Fees. In accordance with Ordinance No. 30-2004, the Storm Drainage Fees shall be levied on the Property effective November 19, 2004.

<u>Section 4.</u> <u>Effective Date</u>. This resolution shall take effect from and after the date of its passage.
