**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE TO
CHANGE THE NAME OF OLD CALVINE ROAD TO GENEVA POINTE DRIVE
BETWEEN EAST STOCKTON BOULEVARD AND AUBERRY DRIVE**

WHEREAS, the City of Elk Grove desires to change the name of Old Calvine Road to Geneva Pointe Drive between East Stockton Boulevard and Auberry Drive as shown on the attached Exhibit A; and

WHEREAS, Section 5026 of the California Streets and Highways Code and Sections 34091.1 and 34092 of the California Government Code authorizes cities to change street names by adoption of resolution, provided a copy of the resolution is forwarded by the City Clerk to the County Clerk and County Surveyor in which the City is located; and

WHEREAS, the County of Sacramento has provided a letter of support to change the name of Old Calvine Road, since the roadway is currently the border of the City of Elk Grove city limits and the County of Sacramento, as provided in the attached Exhibit B.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby approves changing the name of Old Calvine Road to Geneva Pointe Drive between East Stockton Boulevard and Auberry Drive as shown on the attached Exhibit A.


BE IT FURTHER RESOLVED that the City Clerk shall cause a copy of this Resolution to be forwarded to the Sacramento County Clerk and County Surveyor.



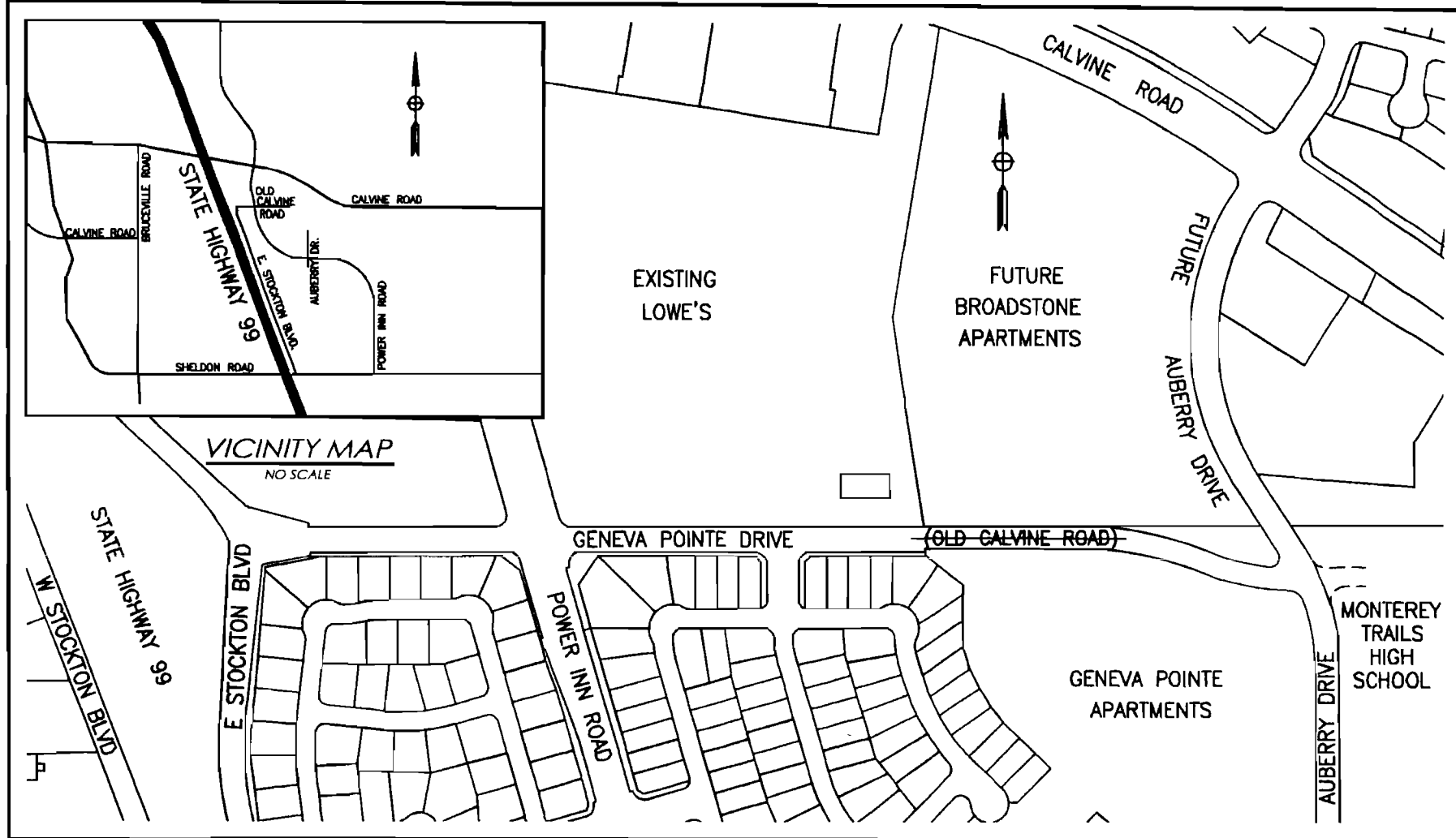

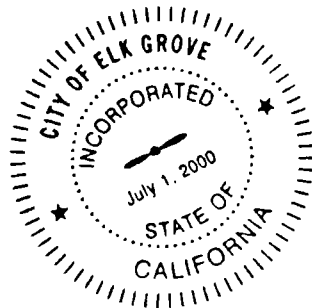
