RESOLUTION NO. 2004-17

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE TO VACATE VARIOUS PUBLIC UTILITY EASEMENTS, A TREE PLANTING AND MAINTENANCE EASEMENT, AND TWO VISIBILITY EASEMENTS ON HOSPENTHAL WAY AND VACATION OF INGRESS AND EGRESS RIGHTS TO EAST STOCKTON BOULEVARD (ABANDONMENT PROCEEDING NUMBER EG-01-146-IP-AB)

WHEREAS, the City received a petition to vacate from owners of property within the City of Elk Grove requesting the City Council of the City of Elk Grove to consider vacation of the subject property; and

WHEREAS, a notice that the City Council of the City of Elk Grove would consider the proposed vacation at a Public Hearing was given in compliance with California Streets and Highways Code, Section 8300, et. seq.; and

WHEREAS, the standards and procedures provided in the Public Streets, Highways and Service Easements Vacation Law, California Streets and Highways Code Section 8300 et seq., the City Council of the City of Elk Grove hereby declares its intention to vacate a public utility easement over Assessor's Parcel No.'s 116-0410-062, and 116-0410-0064 specifically shown on the attached Exhibits; and

WHEREAS, the City of Elk Grove Planning Department has reviewed this project and is recommending that the City Council of the City of Elk Grove find the vacation of the public utility easement as described in the attached exhibits exempt from the provisions of the California Environmental Quality Act (CEQA) under Section 15305 of the CEQA Guidelines; and

WHEREAS, the City of Elk Grove Planning Department has determined that the vacation is consistent with the General Plan and all elements thereof.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove, a political subdivision of the State of California that this City Council hereby finds as follows:

- a. That vacation would be consistent with, and not violate the General Plan and all elements and components thereof for the City of Elk Grove; and
- b. That the public utility easement is unnecessary for present or prospective public use because new easements will be provided once the parcels are developed; and
- c. That the public interest will be served by the herein vacation.

BE IT FURTHER RESOLVED AND ORDERED that the public utility easement over portions of the property shown on the attached Exhibit "A", "B", and "C" is hereby vacated.

BE IT FINALLY RESOLVED AND ORDERED that the City Clerk of the Elk Grove City Council shall cause a certified copy of this Resolution of Vacation, attested by the Clerk under seal, to be recorded in the office of the Recorder of the County of Sacramento.

DESCRIPTION

ALL THAT REAL PROPERTY situated in the City of Elk Grove, County of Sacramento, State of California and being a portion of Lot B and a portion of what was formerly Hospenthal Way as shown on the "Revised Plat of Live Oaks", filed for record in the Office of the Recorder of Sacramento County on October 21, 1987 In Book 179 of Maps, Map No. 23. More particularly described as follows:


COMMENCING at a point common to the Southeast corner of Lot A and the Southwest corner of Lot 26 as shown on said "Revised Plat of Live Oak"; thence along the South line of said "Lot A", the following two (2) courses and distances:


- Along the arc of an 820.00 foot radius curve, concave to the South, through a central angle of 10° 07′ 40″, the chord of which bears South 75° 06′ 00″ West, 144.76 feet;
- South 70° 02' 09" West, 12.00 feet to the true point of beginning;





thence from said point of beginning South 19° 57' 51" East, 52.50 feet to a point on the South line of an existing 12.50 public utility easement shown on said "Revised Plat"; thence South 70° 02' 09" West, 185.77 feet; thence along the arc of a 7.50 foot radius curve, concave to the Southeast, through a central angle of 90°, the chord of which bears South 25° 02' 09" West, 10.61 feet; thence parallel with the East line of Stockton Blvd., being 12.50 feet Easterly, measured at right angles, North 19° 57' 51" West, 61.46 feet; thence along the arc of a non-tangent, 20.00 foot radius curve, concave to the North, through a central angle of 22° 01' 28", the chord of which bears North 81° 02' 53" East, 7.64 feet; thence North 70° 02' 09" East, 185.77 feet to the POINT OF BEGINNING.
