

RESOLUTION NO. 2017-030

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO CONTRACT C-16-499 WITH ROEBBELEN CONSTRUCTION MANAGEMENT SERVICES, INC. TO MONITOR AND MAINTAIN COMPLIANCE WITH THE MITIGATION MONITORING AND REPORTING PROGRAM FOR THE CIVIC CENTER PROJECT IN THE AMOUNT OF \$33,845, FOR A TOTAL EXPENDITURE OF FUNDS OVER THE CONTRACT TERM NOT-TO-EXCEED \$2,044,365

WHEREAS, on September 28, 2016 the City entered into a contract with Roebbelen Construction Management Services, Inc. (RCMS) to perform construction management services for the Civic Center South Project (Project); and

WHEREAS, RCMS has performed required services admirably; and

WHEREAS, additional services to monitor and maintain compliance with the Project's Mitigation Monitoring and Reporting Program (MMRP) are required; and

WHEREAS, RCMS provided scope and fee proposals for the added services from 3 qualified environmental sub-consultants; and

WHEREAS, Foothill Associates provided the best value for the City by providing the lowest cost proposal for the required scope of work; and

WHEREAS, Foothill Associates has a proven history with the City of providing excellent work similar in nature to the required services for this Project.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove authorizes the City Manager to execute an amendment to contract C-16-499 with Roebbelen Construction Management Services, Inc. in substantially the form attached hereto to monitor and maintain compliance with the Mitigation Monitoring and Reporting Program for the Civic Center project in the amount of \$33,845, for a total expenditure of funds over the contract term not-to-exceed \$2,044,365.




