

**RESOLUTION NO. 2017-045**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
DISPENSING WITH COMPETITIVE BIDDING PURSUANT TO ELK GROVE MUNICIPAL  
CODE SECTION 3.42.180(B)(3) AND AUTHORIZING THE CITY MANAGER TO  
EXECUTE A PURCHASE ORDER WITH TYR TACTICAL FOR THE PURCHASE OF  
BODY-WORN BALLSTIC VESTS IN AN AMOUNT NOT TO EXCEED \$52,000**

**WHEREAS**, the Elk Grove Police Department has 137 sworn positions, 17 of which are SWAT; and

**WHEREAS**, the Department is interested in purchasing safe, reliable, high quality body-worn ballistic vests for its SWAT Team members; and

**WHEREAS**, the Department conducted research and a trial of the country's leading manufacturers of law enforcement ballistic vests; and

**WHEREAS**, ballistic vests provide law enforcement protection against firepower from many types of weaponry; and

**WHEREAS**, after several months of testing and evaluation, TYR Tactical was found to have a superior product offering the most protection, comfort, and wearability; and


**WHEREAS**, pursuant to Elk Grove Municipal Code Section 3.42.180(B)(3), the City may dispense with the formal competitive bidding process for equipment when, in the judgment of the City Council, formal competitive bidding is not in the best interest of the City, and, for the reasons presented, seeking formal competitive bids for the proposed equipment here is not in the best interest of the City.

**NOW, THEREFORE, BE IT RESOLVED** that, for the reasons presented, the City Council of the City of Elk Grove hereby dispenses with formal competitive bidding pursuant to Elk Grove Municipal Code Section 3.42.180(B)(3) and authorizes the City Manager to execute a purchase order with TYR Tactical for the purchase of body-worn ballistic vests in an amount not to exceed \$52,000.


