

**RESOLUTION NO. 2017-066**

**A RESOLUTION OF INTENTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE TO GRANT A FRANCHISE AGREEMENT AMENDMENT TO ALLIED WASTE SERVICES OF NORTH AMERICA LLC FOR RESIDENTIAL REFUSE COLLECTION AND TRANSPORTATION TO DISPOSAL FACILITIES AND RECYCLABLES, GREEN WASTE AND E-WASTE COLLECTION, TRANSPORTATION, PROCESSING AND MARKETING AND TO SET A PUBLIC HEARING DATE FOR CONSIDERATION OF A FRANCHISE AMENDMENT**


**WHEREAS**, Allied Waste Services of North America, LLC ("Allied") has applied to the City of Elk Grove ("City") to amend the existing Franchise Agreement (C-15-064) to include a requirement to perform Utility Billing Services starting July 1, 2017; and

**WHEREAS**, the City Council of the City of Elk Grove ("City Council") wishes to adopt a resolution, pursuant to Elk Grove Municipal Code Section 30.30.020, declaring its intention to amend the existing contract (C-15-064) to require Allied to assume responsibility for Utility Billing Services starting July 1, 2017 and setting a public hearing at which all persons having any objection to the granting thereof may appear before the City Council and be heard thereon.


**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby orders and determines as follows:

- 1) The City Council declares its intention to amend the existing Franchise Agreement (C-15-064) with Allied Waste Services of North America LLC to require Allied to assume responsibility for Utility Billing Services for residential refuse collection and transportation to disposal facilities and recyclables, green waste and e-waste collection, transportation, processing and marketing, starting July 1, 2017; and
- 2) A Public Hearing on the above-referenced proposed amendment shall be held at the time and place specified in the public notice included herein as Exhibit A, which the City Clerk of the City is hereby directed to publish at least once in a newspaper of general circulation in the City within fifteen (15) days after the passage of the Resolution.

**NOTICE IS HEREBY GIVEN** that on **Wednesday, April 12, 2017, at the hour of 6:00 p.m.**, or as soon thereafter as the matter may be heard, the Elk Grove City Council will conduct a public hearing at City Hall in the Council Chambers, 8400 Laguna Palms Way, Elk Grove, California, to consider the following matters:

1. To grant an exclusive franchise to Allied Waste Services of North America LLC (“Applicant”) for Residential Refuse Collection and Transportation to Disposal Facilities and Recyclables, Green Waste and E-Waste collection, Transportation, processing and marketing in accordance with Elk Grove Municipal Code Chapter 30.30; and
2. ~~To amend the existing contract (C-15-064) with Applicant requiring Applicant to assume responsibility for Utility Billing Services starting July 1, 2017.~~

At the time set for the public hearing for consideration of this application for a refuse contract, City Council shall:

1. Consider the Applicant's ability to carry out the services proposed to be provided by the contract, the financial and business experience and standing of the Applicant, and any other pertinent factors, including the public interest served; and
2. Hear the application and the comments of interested persons.

The City Council may adjourn the public hearing from time to time at the City Council's discretion. Following the conclusion of the hearing, the City Council shall decide if the contract shall be granted.


