

**RESOLUTION NO. 2017-100**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE AN ON-CALL SERVICES  
CONTRACT WITH MICHAEL BAKER INTERNATIONAL TO PERFORM PLANNING  
SERVICES FOR THE DEVELOPMENT SERVICES DEPARTMENT**

**WHEREAS**, the City of Elk Grove (City) Planning division has relied heavily on a contract staffing model organization since incorporation; and

**WHEREAS**, on March 22, 2017, City Council approved five, core-level staff positions within the Planning division to promote stability and retain institutional knowledge as the City evolves and matures in the decades to follow; and

**WHEREAS**, the current contract with Michael Baker International (MBI) will terminate on May 25, 2017; and

**WHEREAS**, the purpose of this new on-call contract (Contract) with MBI is to cover existing task orders, including current planning services, beyond the termination date of the current contract to minimize interruption in planning services and projects and to help facilitate a smooth transition to core-level staff in the coming months; and

**WHEREAS**, the Contract is also intended to serve as a multi-year, on-call contract for various planning services (i.e. current planning, long-range planning, environmental and special project services) to augment core-level staff as warranted by increasing workload within the division.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an on-call services contract with Michael Baker International in substantially the form presented to perform planning services for the Development Services Department.




