**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURE
PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.140(B)(3) AND
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE
LEGAL SERVICES AGREEMENT WITH BEST BEST & KRIEGER, LLP IN AN
AMOUNT NOT TO EXCEED BUDGETED AMOUNTS**

WHEREAS, the City is in need for outside legal services to assist the City with pending housing litigation and related matters; and

WHEREAS, the City has previously retained the law firm of Best Best & Krieger ("BB&K") to assist the City with such legal matters; and

WHEREAS, in order to accommodate the additional anticipated legal services to be provided to the City by BB&K, an amendment to the Agreement for Legal Services is appropriate; and

WHEREAS, for the reasons presented, pursuit of the formal request for proposal process for the additional legal services is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an amendment to the Agreement for Legal Services with BB&K, in substantially the form presented.
