

**RESOLUTION NO. 2023-063**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH FORD-F, INC., A CALIFORNIA CORPORATION DBA ELK GROVE FORD, FOR THE PURCHASE OF ONE NEW UNUSED FORD F250 SUPER CAB WITH AN 8-FOOT SERVICE BODY IN AN AMOUNT NOT-TO-EXCEED \$50,500**

**WHEREAS**, the City of Elk Grove's Fleet division maintains all existing City vehicles and procures additional vehicles when necessary; and

**WHEREAS**, the City's Operations and Maintenance division (O&M) currently outsources drainage maintenance; and

**WHEREAS**, as part of the adopted Fiscal Year 2022-23 Budget, O&M will be implementing a 10-year preventative maintenance plan for the maintenance, repair, inspection, and cleaning of storm drain lines. The truck identified for this purchase will be used by the Senior Drainage Maintenance Technician; and

**WHEREAS**, in February 2023, the City announced a formal Invitation to Bid (ITB) for one new unused Ford F250 Super Cab with an 8-foot service body; and

**WHEREAS**, Elk Grove-F, Inc., a California corporation dba Elk Grove Ford met all of the requirements of the ITB, and was therefore found to be the lowest responsive and responsible bidder; and

**WHEREAS**, sufficient funding is identified in the Public Works Operations and Maintenance division's Fiscal Year 2022-23 operating budget for this purchase.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a contract with Elk Grove-F, Inc., a California corporation dba Elk Grove Ford, in substantially the form presented, to purchase one new unused Ford F250 Super Cab with an 8-foot service body in an amount not-to-exceed \$50,500.
