RESOLUTION NO. 2023-072

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE APPROVING A SUMMARY VACATION OF A PORTION OF A DRAINAGE EASEMENT FOR DRAINAGE DITCH PURPOSES OVER PROPERTY LOCATED AT 8700 MECCA ROAD [APN 122-0300-013] (CEQA EXEMPT)

WHEREAS, a 15-foot wide drainage easement was dedicated to the County of Sacramento ("County") per deed recorded in Book 19720524 Page 24, Official Records of Sacramento County ("Freeno Drainage Easement"); and

WHEREAS, the County quitclaimed to the City their rights to the Freeno Drainage Easement per deed recorded in Book 20220524 Page 0395, as the County no longer maintains drainage easements in the City of Elk Grove; and

WHEREAS, staff has determined that a portion of the Freeno Drainage Easement as described in Exhibit A Legal Description and depicted on Exhibit B Plat to accompany Legal Description is no longer required for drainage ditch purposes as the drainage ditch has been realigned; and

WHEREAS, a portion of the Freeno Drainage Easement has been determined by staff to be excess and there are no public facilities nor are there any underground drainage pipes within the easement and the portion is not required for any drainage purposes and therefore a portion of the easement should be vacated; and

WHEREAS, the vacation of a portion of the easement may qualify as a project under the California Environmental Quality Act (CEQA), Public Resource Code §§21000-21189.3, but is exempt, as stated below; and

WHEREAS, Section 15305 (Minor Alterations in Land Use Limitations) of Title 14 of the California Code of Regulations (State CEQA Guidelines) provides an exemption from CEQA for projects that do not result in any change in land use or density on sites with less than twenty percent slope, such as lot line adjustments, minor encroachment permits, and reversion to acreage; and

WHEREAS, based on staff's review of the vacation, no special circumstances exist that would create a reasonable possibility that granting the vacation will have a significant effect on the environment.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Elk Grove hereby finds the vacation of a portion of the easement exempt from the provisions of CEQA under Section 15305 (Minor Alterations in Land Use Limitations) of Title 14 of the California Code of Regulations based upon the following findings:

<u>Finding:</u> The vacation of a portion of the easement is exempt from environmental review under CEQA pursuant to Section 15305 of the State CEQA Guidelines.

<u>Evidence</u>: The proposed action involves the vacation of a portion of an easement for drainage ditch and incidental purposes. The action would not increase the density of development in these areas. The site is relatively flat. Therefore, the proposed action qualifies for the Section 15305 exemption and no further environmental review is required.

AND BE IT FURTHER RESOLVED, that the City Council of the City of Elk Grove hereby finds the summary vacation to be consistent with the City's General Plan as required by Elk Grove Municipal Code Section 23.10.030 and Government Code Section 65402(a) based upon the following finding:

Finding: The portion of the Freeno Drainage Easement to be summarily vacated is no longer required as this portion of the easement has been superseded by realignment of the drainage ditch.

Evidence: The summary vacation is consistent with the General Plan as it allows continued maintenance of drainage facilities. General Plan Policy ER-2-18 states drainage facilities shall be properly maintained to ensure their proper operation during storms.

AND BE IT FURTHER RESOLVED, that the City Council of the City of Elk Grove hereby finds:

- a. The summary vacation of a portion of the Freeno Drainage Easement is being made pursuant to Division 9, Part 3, Chapter 4 of the Streets and Highways Code, Summary Vacation Sections 8330 through 8336, inclusive; and
- b. The portion of the Freeno Drainage Easement being vacated is described in Exhibit A Legal Description and depicted on Exhibit B Plat to accompany Legal Description, attached hereto and incorporated herein by reference; and
- c. That a portion of the Freeno Drainage Easement is not necessary for present or prospective public use, there are no other public facilities within the Freeno Drainage Easement, and the public interest will be well served by the herein vacation.

AND, BE IT FURTHER RESOLVED, that the summary vacation of a portion of the Freeno Drainage Easement, as described in Exhibit A and as depicted on Exhibit B, is hereby approved and vacated and shall no longer constitute a drainage easement;

AND, BE IT FINALLY RESOLVED, that the City Clerk of the City of Elk Grove shall cause a certified copy of this Resolution of Vacation and Exhibits A and B, attached hereto and attested to by the City Clerk under seal, to be recorded in the Office of the County Recorder of the County of Sacramento.

Beginning at the Northwest Corner of Lot "A" as shown on the Parcel Map Recorded in Book 5, at Page 25, Official Records of Sacramento County, thence along the North line of said Lot "A" North 88°15'00" East, 40.00 feet; thence leaving said North line South 60°47'06" East, 29.15 feet to the South line of the 15' Drainage Easement Recorded in Book 720524, Page 795, Official Records of Sacramento County; thence along said South line South 88°15'00" West, 65.00 feet to the West line of said Lot "A"; thence leaving said South line along said West line of Lot "A" North 01°44'42" West, 15.00 feet to the Point of Beginning, containing 787 square feet more or less.

The Basis of Bearings for this description is the North line of Lot "A" being North 88°15'00" East, as shown on the Parcel Map filed in Book 5 of Parcel Maps at page 25, Official Records of Sacramento County.


