

**RESOLUTION NO. 2023-078**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FOR OFFICER  
WELLNESS AND MENTAL HEALTH RESOURCES FROM THE BOARD OF STATE  
AND COMMUNITY CORRECTIONS AND AMEND THE POLICE DEPARTMENT'S  
BUDGET TO APPROPRIATE GRANT FUNDS IN THE AMOUNT OF \$89,866.58**

**WHEREAS**, the Board of State and Community Corrections (BSCC) Officer Wellness and Mental Health Grant Program provides grant funding for the purpose of improving officer wellness and expanding mental health resources; and

**WHEREAS**, BSCC has appropriated \$89,866.58 to the City of Elk Grove; and

**WHEREAS**, funds under this program must be used in accordance with Assembly Bill 178, Chapter 45, Statutes of 2022; and

**WHEREAS**, the Elk Grove Police Department desires to expand upon the wellness services offered to officers at the Department in accordance with the guidelines set forth by Assembly Bill 178.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to:

- 1) Accept the awarded grant funding in the amount of \$89,866.58 from the BSCC for the purpose of improving officer wellness and expanding mental health resources in accordance with Assembly Bill 178; and
- 2) Take all action and execute all documents and/or agreements reasonably necessary to receive the grant funding, all subject to approval of any documents and/or agreements as to form by the City Attorney; and
- 3) Amend the Police Department's revenue and expense budget in Fund 210 (BSCC) equal to the amount received and expended each fiscal year until the total grant award has been received and expended.
