A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURE PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.188(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE CONTRACT WITH AZTECA SYSTEMS, LLC, FOR THE LICENSING AND MAINTENANCE OF THE CITYWORKS COMPUTERIZED MAINTENANCE MANAGEMENT SYSTEM FOR THE PUBLIC WORKS DEPARTMENT FOR A SIX YEAR TERM AND A TOTAL NOT-TO-EXCEED AMOUNT OF \$616,997.51

WHEREAS, staff previously solicited and received proposals for Computerized Maintenance Management System software, and proposals from consultants for implementation utilizing the City's current Geographic Information System (GIS); and

WHEREAS, staff reviewed all proposals and found that Cityworks, a GIS-centric Computerized Maintenance Management System software solution, offered through Azteca Systems, LLC, best met the key requirements of the Request for Proposals; and

WHEREAS, sufficient funding is identified in the Fiscal Year 2022-23 Budget for the first year of licensing for the Cityworks platform, staff has requested sufficient funding in the Fiscal Year 2023-24 Budget for the second year, and costs for future years will be included in the respective fiscal year budgets for the term of the contract; and

WHEREAS, staff has utilized Cityworks for two years, has positively grown internal operations, agrees Cityworks has met current expectations and continues to improve functions; and

WHEREAS, the City Council finds that pursuing a formal request for proposal procedure for the proposed software licensing and maintenance is not in the best interest of the City as this would cause interruption in service and may result in increased costs and Cityworks was previously selected as the best overall value for the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Dispenses with the formal request for proposal procedure pursuant to Elk Grove Municipal Code Section 3.42.188(B)(3); and
- 2) Authorizes the City Manager to execute an amendment to the contract with Azteca Systems, LLC, in substantially the form presented, for the licensing and maintenance of the Cityworks software for a six-year period, for a total not-to-exceed amount of \$616,997.51.
