A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A PARTNER AGENCY AGREEMENT WITH SACRAMENTO STEPS FORWARD TO BECOME A PARTICIPATING AGENCY IN THE HOMELESS MANAGEMENT INFORMATION SYSTEM

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) and the federal partners, along with other planners and policymakers, use aggregate data from the Homeless Management Information System (HMIS) to better inform homeless policy and decision making at the federal, state, and local levels; and

WHEREAS, HMIS participation is a statutory requirement for recipients and subrecipients of the Continuum of Care (CoC) Program; and

WHEREAS, Sacramento Steps Forward (SSF) is designated as the Sacramento CoC Lead Agency serving as the Collaborative Funding Applicant, HMIS Lead Agency, and operator for the Coordinated Entry System (CES); and

WHEREAS, the City of Elk Grove is an active participant in the Sacramento CoC; and

WHEREAS, the City desires to become a Partnering Agency in the Sacramento HMIS with the ability to share localized data to provide services to people who are homeless or are at risk of becoming homeless.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager, or designee, to execute and file the HMIS Partner Agency Agreement with SSF, in substantially the form presented, to become a Participating Agency in the HMIS.

BE IT FURTHER RESOLVED, that the City Council of the City of Elk Grove hereby authorizes the City Manager, or designee, to execute all documents and take all actions necessary to implement and administer the HMIS as contemplated by the HMIS Partner Agency Agreement.
