## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AMENDING THE FISCAL YEAR 2023-24 BUDGET AND 2023-2028 CAPITAL IMPROVEMENT PROGRAM FOR THE GRANT LINE ROAD AND WILTON ROAD OPERATIONAL IMPROVEMENTS PROJECT (WTR091) EXCHANGING FEDERAL FUNDS FOR LOCAL FUNDS FROM THE OLD TOWN AREA STREETSCAPE – PHASE 2 PROJECT (WTR012) FOR PRELIMINARY ENGINEERING AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE A FUNDING EXCHANGE AGREEMENT WITH SACOG

**WHEREAS**, in April 2023, Caltrans Office of Local Assistance identified and City staff were made aware of a funding type and project scope issue associated with the federal grant programmed for the Grant Line Road and Wilton Road Operational Improvements Project (WTR091); and

**WHEREAS**, staff has identified the need to remove the federal funds from the Grant Line Road and Wilton Road Operational Improvements Project (WTR091) and use local funds for preliminary engineering work; and

**WHEREAS**, staff identified the Old Town Area Streetscape – Phase 2 Project (WTR012) as a good candidate to exchange local funds for federal funds without creating any risk to the project schedule or delivery; and

**WHEREAS**, a funding exchange letter agreement with SACOG is needed to exchange local funds for federal funds; and

**WHEREAS**, the Grant Line Road and Wilton Road Operational Improvements Project (WTR091) and Old Town Area Streetscape – Phase 2 Project (WTR012) are included in the approved 2023-2028 Capital Improvement Program and the approved Fiscal Year 2023-24 Budget.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby:

- Amends the FY 2023-2024 Budget and 2023-2028 Capital Improvement Program for the Grant Line Road and Wilton Road Operational Improvements Project (WTR091) by removing \$500,000 of Federal Capital Grant (Fund 301) funds and adding \$500,000 of Elk Grove Roadway Fee (Fund 328) funds from the Old Town Area Streetscape – Phase 2 Project (WTR012).
- 2) Amends the 2023-2024 Budget and 2023-2028 Capital Improvement Program for the Old Town Area Streetscape – Phase 2 Project (WTR012) by removing \$500,000 of Elk Grove Roadway Fee (Fund 328) and adding \$500,000 of Federal Capital Grant (Fund 301) from the Grant Line Road and Wilton Road Operational Improvements Project (WTR091).
- Authorizes the City Manager or designee to execute a funding exchange letter agreement with SACOG for the Grant Line Road and Wilton Road Operational Improvements Project (WTR091).
