

RESOLUTION NO. 2023-232

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
TO ABANDON PROCEEDINGS OF ANNEXATION NO. 30 TO STREET
MAINTENANCE DISTRICT NO. 1, ZONE 5-AA**

WHEREAS, the City Council adopted Resolution No. 2003-82 on April 16, 2003, which established the City of Elk Grove Street Maintenance District No. 1; and

WHEREAS, the City Council approved Resolution No. 2005-250 on August 24, 2005, which approved the Engineers Report that established Zone 5 of the City of Elk Grove Street Maintenance District No. 1; and

WHEREAS, on August 9, 2023, the City Council adopted Resolution No. 2023-180, to annex territory into Street Maintenance District No. 1, Zone 5-AA; and

WHEREAS, staff has determined that Annexation No. 30 of Street Maintenance District No. 1, Zone 5-AA is not recommended at this time for this project and that the project can annex under a new annexation at a future date prior to building permit issuance; therefore, staff recommends that the proceeding to complete the above annexation be abandoned by the City Council. The certificate of the City Clerk providing notice of the abandonment is attached as Exhibit A and incorporated by reference.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Elk Grove as follows:

Section 1. Abandonment of Proceedings. Based upon the foregoing, the City Council hereby orders that all proceedings of Annexation No. 30 of Street Maintenance District No. 1, Zone 5-AA be abandoned.

Section 2. Recording of Notice. The City Clerk is hereby directed to record, with the Sacramento County Recorder's Office, a certified copy of this Resolution of Abandonment pursuant to Section 3117 of the California Street and Highways Code.

Section 3. Effective Date. This Resolution shall take effect immediately upon its passage.


