**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDING FOR AN
ELECTRIC BICYCLE AND SCOOTER LENDING LIBRARY FROM THE SACRAMENTO
AREA COUNCIL OF GOVERNMENTS AND AMEND THE FISCAL YEAR 2023-24
BUDGET TO APPROPRIATE GRANT FUNDS UP TO THE AMOUNT OF \$250,000**

WHEREAS, the Sacramento Area Council of Governments (SACOG) provides grant funding opportunities for member agencies; and

WHEREAS, the Mode Shift program invests in, tests, and expands new and existing programs that reduce car trips, provide new mobility solutions, and make options like biking, walking, taking transit, and sharing rides the easy choice for all types of trips; and

WHEREAS, the City of Elk Grove (City) desires to establish an electric bicycle and scooter lending library designed to reduce vehicle miles traveled and greenhouse gas emissions; and

WHEREAS, promoting a sustainable community and planning for future transportation technologies and innovations are Council goals.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to:

- 1) Accept the awarded grant funding up to \$250,000 from the Sacramento Area Council of Governments to implement an electric bicycle and scooter lending library; and
- 2) Execute the grant Subrecipient Agreement in substantially the form provided with the accompanying staff report; and
- 3) Take all action and execute all documents and/or agreements reasonably necessary to receive the grant funding, all subject to approval of any documents and/or agreements as to form by the City Attorney; and
- 4) Amend the Fiscal Year 2023-24 revenue and expense budget within Fund 247 equal to the amount received and expended each fiscal year until the total grant award has been received and expended as follows:

2471241-3440200: Increase by \$250,000

2471241-5202101: Increase by \$250,000
