

RESOLUTION NO. 2023-243

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURE
PURSUANT TO ELK GROVE MUNICIPAL CODE CHAPTER 3.42.140(B)(3) AND
AUTHORIZING THE CITY MANAGER TO EXECUTE THE SECOND AMENDMENT
TO THE CONTRACT WITH FRANKLIN RANCH PET HOSPITAL, INC. FOR
VETERINARY CARE FOR POLICE CANINES, MODIFYING PRICING THROUGH
NOVEMBER 1, 2026**

WHEREAS, the Elk Grove Police Department's Canine Unit is made up of six police canines and their police officer handlers; and

WHEREAS, police canines require medical services/treatment and emergency care, along with boarding services at times; and

WHEREAS, staff has contracted with Franklin Ranch Pet Hospital, Inc. (Franklin Ranch) since 2017 for veterinary and boarding services; and

WHEREAS, Franklin Ranch is a local hospital that has provided superior service and has maintained the same pricing since 2017; and

WHEREAS, for the reasons presented, pursuing a formal request for proposal process for police canine veterinary care is not in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposal procedure pursuant to Elk Grove Municipal Code Section 3.42.140(B)(3) and authorizes the City Manager to:

1. Execute a second amendment to the contract with Franklin Ranch Pet Hospital, Inc. for police canine veterinary care, modifying pricing through November 1, 2026.
2. Execute all future amendments to the agreement concerning extensions of time and increases to pricing for services as allowed by the contract, provided that such amendments do not result in an increase to the total compensation paid to Franklin Ranch Pet Hospital, Inc.
