

RESOLUTION NO. 2024-004

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL BIDDING PROCEDURE PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.180(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH FOLSOM LAKE FORD, A CALIFORNIA CORPORATION FOR THE PURCHASE OF TWENTY-TWO REPLACEMENT AND FOUR ADDITIONAL POLICE VEHICLES FOR A TOTAL CONTRACT AMOUNT NOT-TO-EXCEED \$1,388,000

WHEREAS, the City of Elk Grove's Fleet division maintains all City vehicles and procures replacements and additional vehicles when necessary; and

WHEREAS, the City's Fleet division has identified 14 Police vehicles that will have reached the end of their useful life of City service in Fiscal Year (FY) 2023-24, and eight vehicles are anticipated to reach the end of their useful life of City service in FY 2024-25; and

WHEREAS, with the passage of Measure E, the City Council previously approved the addition of several new positions within the Elk Grove Police Department, and many of these new positions require vehicles to perform their duties, four of which are needed in FY 2023-24; and

WHEREAS, current economic conditions, including the recent United Auto Workers strike and ongoing supply chain and manufacturing delays are creating long lead times for the order and receipt of pursuit rated vehicles; and

WHEREAS, to mitigate these delays and ensure the Police Department has safe and reliable vehicles to serve the community, staff is recommending including the FY 2024-25 replacements as part of the FY 2023-24 purchase; and

WHEREAS, the State of California opened a competitive bidding process for the purchase of pursuit-rated Ford Utility Police Interceptors; and

WHEREAS, Folsom Lake Ford, Inc. (Folsom Lake Ford), a California corporation, was awarded the State of California's large quantity contract for pursuit-rated Ford Police Interceptor vehicles, which was competitively bid and Folsom Lake Ford will honor such state-contract pricing in sales of vehicles to the City; thus, the City is receiving a competitive price and the expenditures of staff time and money to compile the necessary bid documents a second time for a small number of vehicles will not likely result in a better price or an outcome more advantageous to the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

1. Dispenses with the formal bidding procedures for the subject vehicles pursuant to Elk Grove Municipal Code Section 3.42.180(B)(3) and authorizes the purchase of the subject vehicles pursuant to the terms and conditions of the competitively-bid State of California Contract #[1-22-23-14C](#); and
2. Authorizes the City Manager to execute a contract with Folsom Lake Ford, in substantially the form presented, funded as shown in Table 1 below, for the purchase of 22 replacement and four new Ford Police Interceptor vehicles for a total compensation amount not to exceed \$1,388,000.
