## **RESOLUTION NO. 2024-019**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE AN AFFORDABLE HOUSING REGULATORY AGREEMENT ("PARDES 2 REGULATORY AGREEMENT") WITH 8310 POPPY RIDGE LLC, A CALIFORNIA LIMITED LIABILITY COMPANY, FOR THE PARDES 2 PROJECT; AND AN AFFORDABLE HOUSING REGULATORY AGREEMENT AMENDMENT #2 ("REGULATORY AGREEMENT AMENDMENT #2") WITH 8310 POPPY RIDGE LLC, A CALIFORNIA LIMITED LIABILITY COMPANY, AND CRP THE PARDES I LP, A CALIFORNIA LIMITED PARTNERSHIP, FOR THE PARDES PROJECT

WHEREAS, 8310 Poppy Ridge LLC, a California limited liability company ("Developer") proposed to develop a total of 236 units of rental housing (the "Project") at a site located on the southeast corner of Poppy Ridge Road and Big Horn Boulevard (APNs 132-0290-053 and 132-0290-054) (the "Property"); and

**WHEREAS**, on April 26, 2023, the City Council authorized the City Manager to execute an Affordable Housing Regulatory Agreement ("Regulatory Agreement") for the Project; and

**WHEREAS**, on September 12, 2023, the City Council authorized the City Manager to execute an Affordable Housing Regulatory Agreement #1 ("Regulatory Agreement Amendment #1") for the Project; and

**WHEREAS**, on October 12, 2023, the Developer filed Parcel Map 23-001 ("Parcel Map") with Sacramento County, which subdivided the parcel for development in two parcels; and

**WHEREAS**, on November 9, 2023, the Developer sold Parcel 1 of the Parcel Map ("Parcel 1") to CRP The Pardes 1 LP, a California limited partnership ("Parcel 1 Developer"); and

**WHEREAS**, the Developer continued to retain ownership of Parcel 2 of the Parcel Map ("Parcel 2"); and

**WHEREAS**, subsequent to the ownership transfer of Parcel 1, the Developer and Parcel 1 Developer requested to modify the Regulatory Agreement to separate the obligations of the two parcels, which have separate legal ownership; and

**WHEREAS**, Section 38 of the Regulatory Agreements allows for amendments and modifications when in writing and executed by the Owner and the City; and

**WHEREAS**, staff prepared and negotiated an amendment to the Regulatory Agreement that removes the Parcel 2 regulatory obligations from Parcel 1 ("Regulatory Agreement Amendment #2"), and a separate Regulatory Agreement restricting the affordability of seven of the 140 units planned for Parcel 2 ("Pardes 2 Regulatory Agreement"); and **WHEREAS**, the Regulatory Agreement Amendment #2 and Pardes 2 Regulatory Agreement result in a small increase in the overall number of restricted affordable units and benefit the City in meeting its residents' housing needs and progress toward its Regional Housing Needs Allocation.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute an Affordable Housing Regulatory Agreement ("Pardes 2 Regulatory Agreement") with 8310 Poppy Ridge LLC, a California limited liability company, for the Pardes 2 Project; and an Affordable Housing Regulatory Agreement Amendment #2 ("Regulatory Agreement Amendment #2") with 8310 Poppy Ridge LLC, a California limited liability company, and CRP The Pardes I LP, a California limited partnership, for the Pardes Project, in substantially the forms presented, subject to approval as to form by the City Attorney.
