##### 5.1 **Discussion on the Elk Grove Local Register**

Staff requested recommendations/comments regarding how to proceed with 40-45 historic properties which were recently identified as being potentially eligible to the Elk Grove Local Register. City Staff recommended that the City work with Michael Baker International staff to come up with a formal proposal for nominating these historic properties. The Historic Preservation Committee members agreed with staff's recommendations and expressed that they would like the properties added to the local registry. City staff will update the Historic Preservation Committee with updates at future meetings.

##### 5.2 **Discussion on the Façade Improvement Program**

Senior Planner Kyra Killingsworth gave the staff presentation for this report. Staff provided an update regarding the City of Elk Grove Façade Improvement Program and the City's objective to improve the program by potentially increasing the funding amount for applicants up to \$10,000.
