

Tenant Improvement Tuesdays (Appointment Review & Permit Program)

Purpose: This policy establishes a procedure that allows a small business applicant to schedule an appointment on a Tuesday to meet with the City of Elk Grove's Building and Planning staff along with Fire Department staff, either in person, on a conference call or a virtual meeting for the purpose of performing a plan review and initial approval of a construction permit for a proposed tenant improvement of a Business (B) or Mercantile (M) occupancy, with a maximum floor area of 5,000 square feet. **This program does not include additions to existing tenant spaces.**

- To obtain a reservation you must submit a request to the building division no later than the Friday before the requested Tuesday. You can schedule your T.I appointment by calling (916) 478-2235 or email at: bldonline@elkgrovecity.org

Times will be scheduled in one-hour increments from 8:00 am to 12:00 pm.

Note: Process does not ensure a final construction permit will be issued should additional outside agency approvals be required, such as County Water and Sanitation Department, County Health Department, Environmental Air Quality, etc.

Plan Document Submittal Requirements

- Depending on the scope of work a design professional (Architect/Engineer) may be needed for plan/code compliance.
- Complete a Building Permit Application, Fire Permit Application and pay appropriate fees.
- Complete Disabled Access Accessibility Upgrade Summary Form

Cover Sheet specifying

- Project Name (Spec Tenant Improvement or Tenant Name) and Suite Number

- Project Governing Codes: 2019 California Codes and Standards/ Elk Grove Municipal Code.
- Electrical, Plumbing and Energy Codes

Project Data

- Occupancy Type: B or M Construction Type: VB, II-B, etc. Complete Sheet Index
- Floor Area: (Sq. Ft.) and label all rooms
- Existing building fire systems: fire sprinklers, sprinkler monitoring system or fire alarm system
- Statement of project, Scope of Work and proposed Use of Space/ Business type

Site Plan showing and specifying

- Location of building on the site and tenants or occupancy types adjacent to the proposed tenant improvement, with property line setbacks.
- Show "path of travel" from the proposed Tenant Improvement suite to "accessible parking spaces" and the "public way".
- Floor Plan(s) showing and specifying:
 - All existing and new modifications related to the removal (demolition) and addition of walls, doors, new rooms and "accessible" restrooms. Egress components and egress plan.
- Provide additional detail and specification sheets related to wall type and connection requirements, door size, type and hardware requirements, firewalls, and accessibility details.
- Provide additional plan, detail, and specification sheets, where necessary to show and specify all existing and new mechanical HVAC systems, ducts, intake and exhaust registers and fans, electrical panel(s), light fixtures, outlets and switches and plumbing fixtures and piping, etc.
- Provide Title 24 Energy Compliance Documents.
- Include structural calculations (where applicable).

Fees

Consult with a Permit Technician for building permit fees. Development Impact Fees may be applicable if the use of the tenant space or building has changed.
