# **Conditions & Restrictions**

#### Attachment #1

- Permittee shall at all times give strict attention to the safety and right of the traveling public. Moving shall be done during daylight hours except between the hours of 7:00 am 8:30 am and 4:00 pm 6:00 pm. No moving shall be permitted Saturdays, Sundays, legal holidays, or when visibility is less than 1,000 feet.
- 2. All vehicles and loads with length, width, or overhang in excess of the legal limit shall carry one of the following signs mounted both on the front and rear of the vehicle or load: Caution Wide Load Ahead; Caution Wide Load Following; Caution Load Ahead; Caution Long Load Following; Caution Excessive Front Overhang; Caution Excessive Rear Overhang. One of these signs shall also be mounted on each pilot car, which may be convoying the load. The most appropriate of these signs cautioning the traveling public shall be used. The signs shall have a bright yellow background with minimum project area of 440 square inches. The lettering shall be black with 1-inch minimum brush stroke width and 6-inch minimum letter height.
- 3. On all City roads the following pilot car requirements shall apply:

- 4. When crossing bridges or on roads so narrow that it is impractical to keep the entire vehicle and load to the right of the centerline of pavement or traveled way, one flagman shall be posted behind and one flagman ahead of vehicle to warn and direct approaching traffic. No over-legal weight vehicle shall drive onto any bridge when it is obvious to the driver that to do so his overweight vehicle will occupy the bridge at the same time as another truck or bus.
- 5. Notwithstanding any listed roads on this permit or on the attachments thereto, no vehicle shall exceed the limits posted for any road or bridge.
- 6. It is understood and agreed that the Permittee will be held responsible for any damage to City roads, bridges or road facilities resulting from the movement of any equipment named on this permit.
- 7. The Permittee is responsible for all liability for injury to or death of any person or damage to property which may occur through any act or omission of either the Permittee or the City of Elk Grove. In the event any claim, suit or action is brought against the City of Elk Grove, its officers, or employees thereof, by reason of, or in connection with any such act or omission. Permittee shall defend, indemnify, and hold harmless the City, its officers and employees from such claim, suit or action.
- 8. Proof of Automobile Insurance shall be provided at each application submittal.
- 9. Any City employee having reason to believe that a vehicle is not safely loaded or that the height, width, length or weight of a vehicle and load is not as stated on the permit may require the driver to stop and submit to an inspection, measurement, or weighing of the same. The employee may require the vehicle to be driven to the nearest scale facility for this purpose.
- 10. Under this permit, no trees shall be cut, trimmed, used for attaching cables or in any way disturbed unless specifically authorized by a separate Encroachment Permit.
- 11. Single trip permits require notification by the Permittee to the Police Department's Commercial Enforcement Division at (916) 687-1798 before starting the move. When a building is to be moved within the City of Elk Grove, permitee shall give notification 72 hours prior to starting the move to both the City and the fire districts in which the building will be moved. Failure to notify will constitute a violation of this permit.
- 12. Permit is void in all construction zones.
- 13. Permit may be revoked at any time at the discretion of the Director of Public Works.
- 14. Permittee is responsible to check all underpasses, overcrossings, bridges, overhead wires or other structures for impaired vehicle clearance and to arrange clearance or alternative routing before commencing travel.
- 15. Vehicles with loads exceeding 14 feet in width, 17 feet in height, and/or 75 feet in length require police escort. Please contact Elk Grove Police Department, Commercial Enforcement Division at (916) 687-1798. Movers shall give notification 72 hours prior to commencing move. Failure to notify will constitute as a violation of this permit. Attachment #6 has additional information and fee requirements.

#### Attachment #2

CITY OF ELK GROVE ROADS ON WHICH OVERWEIGHT AND OVERSIZE HIGHWAY VEHICLES ARE PERMITTED TO TRAVEL. SPECIAL BRIDGE CROSSING AND GUARD RAILS (SEE ATTACHMENTS #4 AND #5).

This attachment amends Conditions and Restrictions Number 1 to allow Saturday and Sunday movement between sunrise and sunset <u>PROVIDED THAT A PILOT CAR IS NOT REQUIRED</u>. Also, night movement (sunset to sunrise) is allowed ONLY for unladen multi-vehicle combinations, <u>PROVIDED THAT A PILOT CAR IS NOT REQUIRED</u>. No moving shall be permitted Monday through Friday between 7:00 am – 8:30 am and 4:00 pm – 6:00 pm.

This permit does not apply to any roads outside the City of Elk Grove or not maintained by the City of Elk Grove. A separate permit is required for travel on these roads that is issued by the responsible agency.

This permit applies only to the main traveled ways for hereunder-listed roads. It does not apply to any frontage roads, which may lie along the traveled ways.

## Towing Mobile Homes (Attachment #3)

This attachment authorizes towing of mobile homes up to and including 12 feet in width ONLY on the City of Elk Grove roads listed below. SPECIAL BRIDGE CROSSING AND GUARDRAILS (SEE ATTACHMENTS #4 AND #5).

This permit does not apply to any roads outside the City of Elk Grove or not maintained by the City of Elk Grove. A separate permit is required for travel on these roads that is issued by the responsible agency.

This permit applies only to the main traveled ways for hereunder-listed roads. It does not apply to any frontage roads, which may lie along the traveled ways.

### **Bridges in the City of Elk Grove (Attachment #6)**

#### Permit Conditions:

- 1. Permittee shall comply with start and end time on permit.
- 2. City of Elk Grove Police or CHP escort is required. Permit is null and void without escort.
- 3. Authorized route cannot be changed the day of move. Permit is null and void if route is changed.
- 4. Traffic Control shall comply with the current edition of the California Manual on Uniform Traffic Control Devices (MUTCD).
- 5. Permittee is required to clean-up debris and traffic control on public right-of-way within one (1) hour after building or house move. If clean-up does not commence, the City will perform these services and permittee will be responsible for reimbursement of said services.
- 6. Permittee is required to repair all damages to City property and/or right-of-way within 48 hours of notification. All construction and material shall be in accordance with the current edition of the City of Elk Grove Standards and Specifications. If repairs are not completed within the required timeframe or to the City's standards, the City will repair said damages and permittee will be responsible for reimbursement of labor hours and materials.
